Notes on usage

This category of formulas is excellent for patients suffering from Metabolic Syndrome as the product is multi-purposed, helping to improve blood lipid profiles while also providing antioxidant benefits for a healthy inflammatory response and balanced glucose levels. This category of formulas is perfect for those who are overweight, show signs of insulin imbalances, and/or their cholesterol is high and lipid ratios put them at risk for cardiovascular imbalances.

Dosage

- Maintenance: 1 capsule after meal or between meals
- May be taken with meals to enhance the digestion of fats
- For improved cholesterol: 1-2 capsules between meals with Protease
- For both insulin and cholesterol issues: 1 capsule with meals and 1 capsule between meals
