Initial Visit: 8/26/02

BP 100/50 WT 91.5 lbs HT 5'3"

Patient had surgery March 18, 2002 to remove spleen and part of the stomach because of cancer. She had 3 months of chemotherapy, no radiation, which began in May. Esophagus attached to bottom half of stomach and doctors felt the esophagus needs stretching. Has difficulty with getting food down because of reflux and a sore stomach. Has had lots of potassium and magnesium IV during therapy. There is consideration of a bone marrow transplant. First time was in 1998. Diagnosed with lymphoma. Complains of pain in left upper quadrant in spleen area. Currently prescribed morphine.

Enzyme Protocol: 3 DigestZyme at beginning of meals; 2 Gastrozyme following meals; 2 PureZyme morning, mid-afternoon, bedtime; 2 Plantadophilus morning and bedtime.

TEC Office Visit: 9/12/02

BP 94/50 WT 93 lbs

Doing well with weight gain...was up to 97 pounds until mother had a stroke (2 weeks ago) and lost weight due to stress. Still having problems with lots of gas. Trying to wean off pain medication. Is going to see doctors at MD Anderson. Doing minimal exercise and eating what feels good. <u>Since taking enzymes, no nausea or vomiting.</u> Wants something for gas and bloating, will discuss acupuncture with the MD Anderson Dr's.

TEC Office Visit: 11/13/02

WT 102 lbs

Discussed hormone replacement therapy. <u>She is now only using a half tab of morphine and will gradually add enzymes.</u> Blood work shows liver stress (elevated liver enzymes), pt also has Hepatitis C.

Enzyme Protocol: added the following: 2 MasterZyme 2x/day; 2 Protease IFC 3x/day; 2 Antioxidant complex 3x/day; 2 RepairZyme 3x/day; 2 Super CellZyme 3x/day.

TEC Office Visit: 12/4/02

WT 104 lbs

Stopped enzymes after 4-5 days – too many pills, made her nauseated. Discussed new arrangement. Weight is up. Do Liver Detox

Enzyme Protocol - back to original protocol

TEC Office Visit: 8/1/05

Feeling good, using enzymes 60% of the time. Exercises once a week at the gym. Working and will go back full time. Not drinking alcohol now. On hormones for one month. Currently takes Protease 2-3x/day, DigestZyme most of the time, Probiotic in the morning, Protease IFC 2-3x/day, Liver Support 1-2x/day, and vitamins.

Summary
